### Information We Collect From Everyone Who Visits Our Website

Our website automatically receives and records information on our server logs from your browser, including your IP address (which may be considered personally identifiable information in some jurisdictions) browser type, domain names, access times and referring website addresses. ## Information We Collect From Certain People Who Visit Our Website

When you choose to fill out forms on our website, we will collect your personally identifiable information as described below.

Information collected from requesting a Stamp Pass

If you request a STAMP Pass, you provide personally identifiable information such as your name, email address, phone number, mailing address, birthday, and school. We also collect information about how you learned about the program, your interests, and your thoughts about

and experiences with museums. We also give you the option of providing us with certain demographic information.

Information collected from Teen Council members who post articles

If you are a Teen Council Member who posts an article, we post your name and school as well as any photos or other information you provide in the article. Once posted, this information is publically available and could be collected and used by others. In addition, when you post information you grant us the Content License described below. Please keep this in mind as you create your posts. If you would like to post without revealing your name and/or school, please contact us at stamp@philaculture.org.

*Information collected from those leaving a reply* 

If you post a reply to our articles or posts, you provide us with your name, email address, and comments. Once posted, your name and comments are publically available and you grant us the Content License described below.

#### **How We Use Your Personal Information**

We may use your personally identifiable information to contact you to respond to your inquiry, conduct surveys or ask about your opinion of current services or provide information about services that may be offered to you.

We may use your personally identifiable information to send you texts, emails or regular mail. We send some mailings ourselves. Other mailings are sent by third-party vendors we use to help us manage our communications. We may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your personally identifiable information (name, email, address, telephone number) is not transferred to the third-party. In addition, we may share data with trusted partners to help us perform statistical or data analysis, send you email or postal mail, provide customer support, or arrange for deliveries. Your information is aggregated with other STAMP participants so we can analyze trends, improve the STAMP program and to gather information about the STAMP participants as a group. We share our data analysis with current and prospective funders and participating institutions.

We may share the personal information we collect in order to investigate, prevent, or take action regarding suspected illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, or as otherwise required by law. We reserve the right to disclose

your personally identifiable information as required by law when we believe that disclosure is necessary to protect our rights or comply with a judicial proceeding, court order, or legal or administrative process served on us.

Except as provided in this Privacy Policy, we do not share your personally identifiable information with third-parties.

#### You Can Opt-Out of Receiving Certain Emails from Us

We provide you the opportunity to "opt-out" of having your personally identifiable information used for certain purposes.

If you have signed up to receive text messages from us, you may opt-out of receiving them by replying STOP or QUIT to a text.

If you no longer wish to receive emails from us, you may opt-out of receiving them by following the instructions included in each newsletter or communication or by emailing us at info@philaculture.org.

We do not provide the opportunity to opt-out of having your personally identifiable information used to send you notices the law requires us to send to you.

# Our FaceBook Page, Twitter Feed, Instagram Account and Other Third-Party Websites

We are actively involved in social media. To name a few of our social media platforms, we have a FaceBook page, a Twitter feed and an Instagram account. #### **Content License**

If you share any materials, text, information or images with us ("Content"), you grant us a non-exclusive, worldwide, irrevocable, fully paid and royalty-free right and license to use that Content in connection with the STAMP Program, including the right and license to reproduce and publicly display the Content. Your grant of the Content license includes the right to grant sublicenses.

We do not claim any ownership rights in your Content. You will continue to retain all ownership rights in your Content, and you will continue to have the right to use your Content in any way you choose.
